The following items have been discussed at the most recent Faculty of Science Brokerage Meeting:

Group Name Change

From the 1st September 2014, the Faculty of Science Brokerage Group will be re-named the 'Science Placements and Employability Group' (SPEG).

Health and Safety

As a result of the new Placement Learning Code of Practice, all staff involved in completing pre-placement Risk Assessments will receive training throughout September. Further details will be provided nearer the time.

Recognised Good Practice within the Faculty of Science

As a result of placement provider feedback collated by the World of Work and Skills Support Unit, the School of Sport and Exercise Science are currently in the planning stages of introducing 'safe guarding clients' training courses for students. Full details have not been finalised, however the aim is for students to complete the training prior to going out on placement.

Placement Learning Code of Practice

The new Placement Learning Code of Practice was approved by the Academic Board on 23rd June 2014. Business within the Faculty of Science will continue as normal until the official approval intended for the 1st of August. Staff within the World of Work and Skills Support Unit will be meeting with Module Leaders and Placement Coordinators to discuss the changes and plan the implementation of the new Code so that the transition is as smooth as possible.

World of Work Career Centre Updates

Overall Laura Aldridge has completed 81 hours delivery in the first semester and 114 hours delivery in the second semester, making it a total of 195 hours of delivery out of the maximum 240 for the academic year. The second semester has seen the highest take up of delivery from any Faculty.

Laura Aldridge is now taking requests for delivery next year (2014/15).
