Recognised Good Practice within the Faculty of Science

The Faculty of Science Skills Support Unit and Monica Barclay delivered a compulsory Pre Placement Process and Health and Safety session for all Undergraduate Level 6 SPS students, as part of their 'Applied Placement' module. The aim of the session was to inform students of what is required of them before they go out on placement, in line with the new Code of Practice and the Health and Safety at Work Act. Praise for the session was received from the School.

DBS

Placements

The limited staff resources to support placement administration is impacting the number of PBS students currently out on placement. The School of Sport and Exercise Science reported that they would not be able to deliver their placement module without the support from the Faculty of Science Skills Support Unit. Feedback from students also supports this and the team's support has positive comments through the NSS. The Faculty are currently auditing the impact of the Code of Practice on staff resources and will feedback.

Amongst PBS students returning from their yearlong placement, it appears some are struggling to integrate back into the new cohort. Ongoing discussions with the School of Pharmacy and Biomolecular Sciences are taking place to find ways in which these students can be supported.

Faculty of Science Skills Support Unit

It appears students continue to struggle differentiating the Faculty's World of Work and Skills Support Unit, from the World of Work Careers Centre and often end up handing up paperwork into Kingsway House and turning up for Employability Events at Byrom Street. Feedback from students and staff suggest that the World of Work and Skills Support Unit title does not reflect the support the Unit offers to students. This concern has been raised within the Faculty.

Extra-Curricular activities offered by the Faculty

The Faculty of Science Skills Support Unit are currently investigating the extra-curricular activities that take place within the Faculty in order to support the development of recognition of achievement for students through the HEAR (Higher Education Achievement Report).
